Kaye Spooner read a letter she prepared regarding her findings of the Elk County voter rolls.

EMS

Ken Mitchell presented the monthly report for March. There were 17 total runs with total collections being \$15,567.10. Mr. Mitchell stated the KRAF Grant was approved for the power pro xt cot. The KBEMS amount is \$13,189.23 and the County match is \$5,652.53 with the total amount of the power cot being \$18,841.76.

Sheriff

John Walker presented the monthly report for March and a 3-year department report. Sheriff Walker present quotes from AT&T for new telephones and updates. Commissioner Kaminska moved and Commissioner Liebau seconded the motion to upgrade the phone system in the Law Enforcement Center in the amount of \$5,869.99 to be paid from the ELC Grant. Motion carried 3-0. Discussion was had regarding installing a communication tower by the Sheriff's Office for the 911 dispatch system. Commissioner Kaminska moved and Commissioner Liebau seconded the motion to accept the quote from Action Communications to install a tower for the 911 dispatch system to improve radio communications at the Law Enforcement Center in the amount of \$6,520.00 to be paid from the 911 Fund.
