The 5-year Emergency Operations Plan is currently under informal review of what is currently finished. Ms. Cordell will do a presentation at the afterschool program in Elk Valley.

County Development

A survey can be completed to help develop the grant application. Ms. Kaminska has sent out a few grant applications to some business owners. The grant is for rural businesses for energy upgrades. Ms. Kaminska will contact SCKEDD regarding the Housing Preservation Grant.

Rural Fire

Todd Winscher stated truck #513 is down with clutch issues.

Sheriff

John Walker stated Courtney Zimmerman was hired as a dispatcher. Sheriff Walker said one dispatcher resigned and one deputy was terminated. The courthouse panic alarm that was installed in 2006 is not working. Sheriff Walker presented two quotes from Response Technologies to replace the alarm system. The Commission would like Sheriff Walker to seek more bids before action is taken.

Elk County Fair Allocations

David Criger would like the commission to consider increasing the County Fairs allocations. Mr. Criger stated Elk County is the lowest budgeted county fair in the State. Mr. Criger said the county needs to think of its youth. The Commission stated they will consider increasing the allocations during the 2024 budget preparation.
