RESOLUTION VACATING A COUNTY ROAD

WHEREAS, the ELK County Commission is vested with the sole authority to determine which roads should be laid out, altered or vacated pursuant to K.S.A. 68-102; and

WHEREAS, the BOARD my vacate any road in the county due to nonuse or the fact that the road does not serve the public at large.

That the below described road be and is hereby vacated due to the same not serving a public purpose and nonuse. That this determination was made following the filing of a petition by an adjoining landowner, the giving of notice pursuant to KSA 68-102a, a viewing by the BOARD and an opportunity for the public to be heard; to wit:

All that portion of Rock Road commencing at the East right of way boundary of Road 21 thence East between Section 1, Township 29 South, Range 11 East and Section 36, Township 28 South, Range 11 East generally following the section line for ¾ of a mile thence South of a ¼ mile thence East a ¼ mile to the section boundary line between Sections 1, Township 29 South, Range 11 East and Section 6, Township 29 South, Range 12 East, thence east approximately 1 mile generally following the line between the North half and South half of the North half of Section 6, Township 29 South, Range 12 East to the West boundary line of Road 23 all in Elk County Kansas. Vacating said Road for its entire length and width as described.

That the County Clerk shall cause a certified copy of this resolution to be filed and recorded in the Office of the Register of Deeds of Elk County, Kansas.

That this resolution shall take effect and be in force effective upon the formal approval of this resolution by the Board of the Elk County Commission.
