Neighborhood Revitalization Program Public Hearing

Chairman Liebau called the Neighborhood Revitalization Program Public Hearing to order at 1:00 p.m. Shari Kaminska presented a handout pertaining to the program. The purpose of the NRP is to incentivize the improvement of existing structures and construction of new structures. The NRP is a declining tax rebate program with a minimum investment requirement of \$10,000. The applicant can not have any delinquent property taxes at the time of application or at any time during their enrollment in the program. It has a 3-year enrollment period which must be renewed by all participating entities. It requires a resolution by the governing body to implement. The County hopes to implement the program by October 1, 2023.

Chairman Liebau closed the NRP hearing at 1:10 p.m.

Ken Mitchell presented the department report for August. There were 19 total runs with total collections being \$16,749.17. Mr. Mitchell stated he will be taking the new ambulance to the State Fair tomorrow.

Appraiser

Jeremy McCully stated the Division of Property Valuation annual statistical and procedural compliance review for the 2023 appraisal year to determine substantial compliance within the county appraiser's office has been completed and Elk County has met all criteria and is determined to be in substantial compliance.

Emergency Management

Erica Cordell stated the monthly outdoor siren test had no issues. Elk County hosted this month's regional KEMA meeting and it was very well attended. Ms. Cordell will be attending the KEMA conference this week.

Public Works

Road

Don Sanders stated Kline Motor will be delivering the new truck in the middle of October 2023.

Maintenance

Mr. Sanders stated the generator is now tied into the Sheriff's Office. The other generator and old shop trucks will be listed on Purple Wave.

Register of Deeds

Stephanie Ollenborger presented the report for August 2023. They had a total of 61 instruments recorded and a total deposit of \$2,851.75.

Community Development

Shari Kaminska stated the E-Community meeting will be on September 13, 2023. The committee will be working on the youth entrepreneurship challenge. Ms. Kaminska will be attending a makerspace summit in Emporia on September 20, 2023. The KEDA Conference in Topeka will be September 26 & 27, 2023. The SCKEDD meeting will be in Wichita on September 28, 2023. Ms. Kaminska has a graphic design intern through Pittsburg State working 20 hours by zoom. The intern is paid through a grant at no cost to the County. They will be working on the Methodist Church project together.

Health

Kandy Dowell stated there are 8 new cases of COVID.

Eagleview Mapping System

Jeremy McCully presented paperwork on the Eagleview mapping system. This system will save Elk County \$19,000 annually if we fly with Chautauqua County and will cut field work down by 85%. The commission is in favor of this system. Mr. McCully will contact Chautauqua County to get more details on the cost.
