Call to Order

### Minutes Approval

Commissioner Russell moved and Commissioner Hendricks seconded the motion to approve the regular meeting minutes of December 11, 2023 as presented. Motion carried 3-0.

## Public Forum

Kaye Spooner spoke of concerns regarding election fraud and election equipment.

## EMS

Ken Mitchell stated Beverly Signer resigned from the EMS Department and the Health Department. Cassidy Brenner has been hired to fill the position. Commissioner Hendricks moved and Commissioner Russell seconded the motion to approve the hire of Cassidy Brenner for the EMS/Health position at \$13.00 an hour. Motion carried 3-0.

## Appraiser

Chris Miller stated the department would like to transfer funds from their budget to their special equipment fund. Commissioner Russell moved and Commissioner Hendricks seconded the motion to transfer \$15,972.97 from the Appraiser's budget to the Appraiser's Equipment Reserve Fund. Motion carried 3-0. Chris Miller presented a quote from Advantage Computer for two monitors and one computer system. Commissioner Russell moved and Commissioner Hendricks seconded the motion to accept the quote from Advantage Computers in the amount of \$1,690.00 for the purchase of two monitors and one computer system. Motion carried 3-0.

### **Emergency Management**

Erica Cordell stated she is continuing to work on getting citizens signed up for the Genasys Alert System. The Regional Hazard Mitigation Plan update is in progress with the state contractor. Ms. Cordell attended the Healthcare Coalition Meeting in Chanute.

#### Treasurer

Rachel Ware stated the Movers System has been down State wide since last week. Mrs. Ware said the County is down on tax collections and this will affect the January distribution if more tax dollars do not come in.

#### **District Court**

Erin Meador requested to transfer \$20,000 to the District Court Equipment Reserve Fund to pay for the new audio system.
