#### **EMS**

Ken Mitchell presented the December 2023 report. There were 15 total runs with total collections being \$8,218.94. Commissioner Hendricks moved and Commissioner Russell seconded the motion to approve the hire of Abigail Bowman as an EMT at \$12.00 an hour. Motion carried 3-0. Mr. Mitchell stated the overhead doors stopped working last Thursday and had to be repaired. The EMS and Health Department are looking at LED signs. The EMS and Health Department will split the cost of the sign.

# **Emergency Management**

Erica Cordell stated the SAMS renewal is completed for 2024. This is the government program that must be current for the county to receive grants. The EMPG 2023 has been approved and we will be receiving the allotted full amount of \$6,864. There was a decrease across the board due to less money be allocated from FEMA to the states. On January 4, 2024 Ms. Cordell attended the first KEMA meeting of the year in Wilson County. The LEPC meeting will be January 18, 2024 at 6:30 p.m. at the Cox Building. This meeting is open to the public. The Storm Fury on the Plains annual storm spotter workshop with NWS is set for February 29, 2024 at 6:30 p.m. at the Cox Building.

# Register of Deeds

Stephanie Ollenborger presented the report for December 2023. They had a total of 44 instruments recorded and a total deposit of \$3,281.00. Mrs. Ollenborger presented 2023 year-end reports.

# Rural Fire

Todd Winscher stated they had a total of seventy-five runs in 2023, thirty of them being rescue runs.

#### Health

Kandy Dowell stated the roof is leaking in the restroom at Health Office and a culvert is plugged causing water to pool around it. The City of Howard is able to remove the culvert if that's what the County would prefer. The Commission stated they would like the city to remove the culvert.

#### Treasurer

Rachel Ware stated more tax payments have been received. This will help with the January distribution.

#### County Clerk

Kerry Harrod stated the Southeast Kansas District meeting will be hosted by Coffey County on Thursday, April 18, 2024. Registration will be from 8:30 a.m. to 10:00 a.m. in the courthouse lobby located at 110 S. 6<sup>th</sup>, Burlington, Kansas

#### Sheriff

John Walker presented the December 2023 department report. Sheriff Walker stated a new system is in the building process called Lightening. This system will take the 911 information and send it straight to the responders (EMS, Fire, Emergency Management). The system will be no cost to the county. The flock system cameras are still waiting on KDOT's approval. The impound yard has 13 vehicles in it, two sold on Purple Wave but were never picked up. The buyers have 15 more days to pick up the vehicles, if they do not the vehicles will be resold. Three of the vehicles are still evidence in ongoing cases. Sheriff Walker stated he will have to get titles on eight of the vehicles. Sheriff Walker stated he has hired two full-time and one part-time dispatcher. Sheriff Walker would like to transfer \$30,000 from the 2023 sheriff's budget to the sheriff equipment reserve fund. Commissioner Hendricks moved and Commissioner Russell seconded the motion to transfer \$30,000 from the 2023 sheriff's budget to the sheriff equipment reserve fund. Motion carried 3-0.

# Community Development

Shari Kaminska will send a letter supporting SB196 to the State. Senate Bill 196 is a bill to restore funding to the LAVTR. Ms. Kaminska will be joining the Moline and Howard Chambers. The County will pay for Ms. Kaminska's dues.
