Chairman Liebau called the regular meeting to order at 1:00 p.m. Commissioner Hendricks and Commissioner Russell were all present as well as County Clerk Kerry Harrod and County Counselor Paul Dean.

#### Minutes Approval

Commissioner Hendricks moved and Commissioner Russell seconded the motion to approve the March 25, 2024 minutes as presented. Motion carried 3-0.

#### Public Forum

Kaye Spooner would like to thank the rural fire department for all their hard work over the last couple of weeks. Thayne Botterweck expressed his concern of his property value declining due to his neighbor's property being full of trash and unkept. Mr. Botterweck asked the commission if there was anything they could do to make his neighbor clean up his property. The commission stated they could not.

# <u>EMS</u>

Ken Mitchell stated truck #206 is back in service. Mr. Mitchell presented the department report for March. There were 20 total runs with total collections being \$8,161.00. # Public Works

## Maintenance

Don Sanders stated the automatic door in the courthouse needs repaired or replaced. The estimated cost for a new door is \$2,00 to \$3,000. Mr. Sanders is working on getting quotes for repairs from Cheney Door. The commission said to replace the door if it needed to be. Mr. Sanders stated Eric Watts will start work on April 23, 2024 in the maintenance department.

#### County Clerk

Kerry Harrod presented the direct expenses for the Presidential Preference Primary Election. ## Property on Dove Road, Moline

Discussion was had regarding listing the property with an agent.

#### Radio Tower

Discussion was had regarding moving the radio equipment off Flint Oaks tower to the Wholesale 23 tower. Erica Cordell presented a quote from Action Communications to move the equipment. This should improve the signal greatly on the eastern side of the county. Commissioner Hendricks moved and Commissioner Russell seconded the motion to approve the quote from Action Communications to move the radio equipment in the amount of \$9,625.92 to be paid out of County General unless another source of funding is found. Motion carried 3-0.

# Road 10 GW/EK Countyline Road

It has been determined that the GW/EK Countyline Road is still an open road and has never been closed. The Elk County Road Department will start maintaining the road. A contract will be drawn up by County Counselor Paul Dean for the Meyer's to sign acknowledging that it is an open road.
