Minutes Approval

Commissioner Hendricks moved and Commissioner Russell seconded the motion to approve the June 10, 2024 minutes as presented. Motion carried 3-0.

Public Forum

EMS

Gillian Beaumont stated a new full-time paramedic was hired and will start work July 7, 2024. The new flag pole is up at the EMS/Health Facility. Jenifer Clatt will attend a meeting on the reporting system on July 8th and 9th.

Appraiser

Chris Miller presented the GIS Maintenance Contract with Kimble Mapping. Mrs. Miller stated \$1,500 will come out of the Sheriff's budget and \$4,500 will come out of the Appraiser's budget. Commissioner Hendricks moved

and Commissioner Russell seconded the motion to approve the Kimble Mapping Contract for the GIS Maintenance in the amount of \$6,000. Motion carried 3-0.

Emergency Management

Ms. Cordell and Chautauqua County Emergency Manager Cody Collier presented at the West Elk summer camp for the sixth through eighth graders on June 18, 2024. They taught hands only CPR and stop the bleed/torniquet basics. Ms. Cordell stated the new antenna is up on the Wholesale 23 tower and Dave Jackson is waiting on the microwave dish for the connection to the windfarm tower. A new windsock was purchased for the airport and should be in in the next day or two. The Road Department will install it as soon as possible. Public Works
