2023 Audit Report

Phil Jarred and Emily Franks with Jarred, Gilmore & Phillips, PA. presented the 2023 Audit Report. Discussion was had regarding their findings. Commissioner Hendricks moved and Commissioner Russell seconded the motion to accept the 2023 Audit Report as presented. Motion carried 3-0.

2025 County & Rural Fire Budget

Phil Jarred and Emily Franks presented the 2025 County & Rural Fire Budgets. Discussion was had regarding the budgets. Commissioner Russell moved and Commissioner Hendricks seconded the motion to increase the Elk County Council on Aging budget by \$10,000 to be used for the senior centers. Motion carried 3-0. Commissioner Russell moved and Commissioner Hendricks seconded the motion to increase the county budget \$13,000 to be able to service the new improvements. Motion carried 3-0. The budget hearing date will be August 26, 2024 at 1:00 p.m. in the commission room of the courthouse. County Clerk Kerry Harrod will publish the Notice of Hearing to Exceed Revenue Neutral Rate and Budget Hearing in the local paper.

EMS

Gillian Beaumont presented the monthly report. Mrs. Beaumont would like to switch phone service from Verizon to US Cellular. Mrs. Beaumont has spoke with the Kansas Board of Nursing and they have given her the authorization to work on the ambulance as a registered nurse.

County Clerk

Kerry Harrod stated she received an open records request regarding the policy for entering the courthouse. Sheriff Walker stated he was working on the request with the County Attorney and the County Counselor.

2025 County & Rural Fire Budget

Commissioner Russell moved and Commissioner Hendricks seconded the motion to have the RNR and Budget hearing on August 26, 2024 at 1:00 p.m. in the commission room of the courthouse. County Clerk Kerry Harrod will publish the Notice of Hearing to Exceed Revenue Neutral Rate and Budget Hearing in the local paper. Motion carried 3-0.

Greenfield Cemetery 2025 Budget

Greenfield Cemetery Treasurer Byrdee Miller stated she has concerns regarding the 2025 budget prepared by Carolyn Brock. County Clerk Kerry Harrod stated Ms. Miller would need to discuss the budget with Ms. Brock to make any changes she would like made to the budget.

Warrants

Commissioner Hendricks moved and Commissioner Russell seconded the motion to pay the warrants in the amount of \$81,535.12. Motion carried 3-0.

Community Development

Shari Kaminska presented a quote in the amount of \$10,530 to disconnect and moved the 11k generator at the courthouse and install it at the 300 N Plum, Moline. Install the whole building automatic transfer switch, excavate conduit and wire, replace four electric sump pumps, and excavate all the discharge lines away from the building. The County would like to thank Van Coble for cutting the trees and shrubs from around the building for free. Commissioner Russell moved and Commissioner Hendricks seconded the motion to accept Frees Plumbing's bid in the amount of \$10,530 to do the work at 300 N. Plum, Moline. Motion carried 3-0. Ms. Kaminska would like to look at the county's procurement policy and make changes if needed.
