Public Forum

EMS

There will be a water shortage regional tabletop exercise in Chanute on November 7 from 9:00 a.m. to noon.

Public Works

Don Sanders stated all blading has stopped due to the dry conditions. The project on Road 9 is almost complete. The Green Ranch bridge was viewed and is currently being worked on. Mr. Sanders said the county should be getting a check from FEMA soon.

Rural Fire

Todd Winscher stated the generator on the rescue truck is bad and he would like to replace it. The commission gave the ok to replace the generator.

Sheriff

John Walker said that Deputy Beaumont has went to part-time and a new deputy has been hired. Sheriff Walker stated Montgomery County contacted him on joining them and a few other counties for a grant through the government for radios. Sheriff Walker has selected Deputy Kelly to be his new undersheriff. Sheriff Walker would like an executive session later in the meeting for non-elected personnel.

Treasurer
