Gillian Beaumont stated Taylor Dory went from part-time to a full-time EMT and Clay Crisswell has been hired as a part-time paramedic. Mrs. Beaumont stated bus #206 needs new tires. Commissioner Russell moved and Commissioner Liebau seconded the motion to approve the change from part-time to a full-time EMT for Taylor Dory from \$13.50hr to \$15.00hr. Motion carried 3-0. Emergency Management

Erica Cordell attended the January monthly KEMA meeting in Montgomery County. All the sirens worked during the January siren test. Elk County received the 2024 EMPG disbursement check in the amount of \$10,493, which was the most the county could earn. Ms. Cordell has been working to have all our deployable assets and equipment updated in the CRMCS (Comprehensive Resource Management and Credentialing System) program. This is a state program and the one used for badging personnel. Ms. Cordell is also working on getting her KCEM (Kansas Certified Emergency Manager) application packet prepared for submission. LEPC (Local Emergency Planning Committee) meeting will be held January 16, 2025 at 6:30p.m. at the Cox Building. This meeting is open to the public. The Storm Fury on the Plains is scheduled for March 5, 2025 at 6:30p.m. at the Cox Building.

Register of Deeds

Stephanie Ollenborger presented the report for December 2024. They had a total of 33 instruments recorded and a total deposit of \$1,361.75. Mrs. Ollenborger presented 2024 year-end reports.

Sheriff

John Walker stated the Charger was sold along with a couple of junk trucks down at the impound. The trucks have been picked up but the Charger has not. Sheriff Walker would like AT&T to trace a phone line 374-2477 to see if it is needed or not. Sheriff Walker stated George Stubblefield has been hired as a jailer, dispatcher, and part-time officer

Ms. Stowe would also like to see more than three commissioners on the board. Having five or more commissioners on the board would provide more of a diverse perspective and better oversite.
