Notice of Revenue Neutral Rate Intent



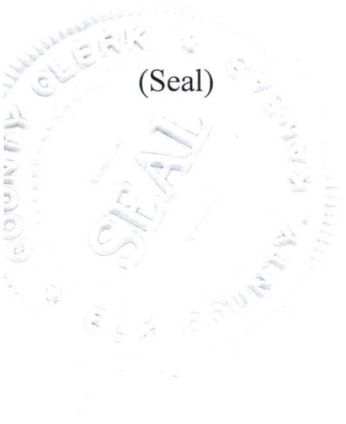

Resolution No. 22-09

A RESOLUTION OF THE ELK COUNTY RURAL FIRE DISTRICT NO. 1, KANSAS TO LEVY A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE;

WHEREAS, the Revenue Neutral Rate for the Elk County Rural Fire District #1 was calculated as 4.195 mills by the Elk County Clerk; and

WHEREAS, the budget proposed by the Governing Body of the Elk County Rural Fire District No. 1 will require the levy of a property tax rate exceeding the Revenue Neutral Rate; and

WHEREAS, the Governing Body held a hearing on August 29, 2022, allowing all interested taxpayers desiring to be heard an opportunity to give oral testimony; and


WHEREAS, the Governing Body of the Elk County Rural Fire District No. 1, having heard testimony, still finds it necessary to exceed the Revenue Neutral Rate.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE ELK COUNTY RURAL FIRE DISTRICT NO. 1:

The Elk County Rural Fire District No. 1 shall levy a property tax rate exceeding the Revenue Neutral Rate of 4.195 mills.

This resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.
